## TUITION PAYMENT OPTIONS

For 2019 – 2020 there are two (2) payment options.

**Full Payment** – A discount of \$100.00 per child is given if the entire tuition amount is received on or before July 15, 2019. The payment must be postmarked or received at the school or parish office on or before July 15, 2019 to be eligible for the discount.

**Payments through FACTS Management** – A variety of payment options are available – including auto-payments and credit cards.

## TUITION ASSISTANCE

**FACTS Management** is used for both the Catholic Diocese of Cleveland assistance and parish assistance. The application is available online at <https://online.factsmgmt.com/aid> Round 1 deadline is March 15, 2019 and Round 2 deadline is June 1, 2019.

**Catholic Diocese of Cleveland Assistance** – Diocesan Tuition Assistance is available. For consideration in Round 1, the FACTS Management application must be submitted by March 15, 2019. Limited Diocesan assistance remains available for the Round 2 deadline of June 1, 2019.

**Parish Assistance** – St. Mary Parish provides assistance based on need as determined by FACTS Management and the amount of funds available. **The application must be received by FACTS Management before March 15, 2019 to be eligible for parish assistance. Only registered students will be considered.**
